



BETWEEN: _____ (hereinafter called 'the Photographer')

AND: _____ (and parent or guardian if a minor) (hereinafter called 'the Property Owner')

CONSIDERATION

In consideration of something of sufficient value to the circumstances e.g. money, prints etc., the receipt and sufficiency whereof is hereby acknowledged by the Property Owner as having been received, both parties hereto agree as follows:

1. *DESCRIPTION OF THE PROPERTY*

The property to which this Agreement applies is, provide detailed information that would identify the property (all of which are hereinafter called collectively the 'Property'). The Property Owner attests to being the sole owner and having the sole right to possession of the property and that no other person has any right to approve the making of photographs of the Property except for the following: names and address of each other person or state NONE.

2. *DESCRIPTION OF THE PHOTOGRAPHS*

This Agreement applies to all photographs of the Property, made by the Photographer on the session dates covered by this agreement (noted below) and to all subsequent reproductions of such photographs of the Property in which the Property may be included intact or in part. (herein collectively called 'the Photographs')

3. *USE OF THE PHOTOGRAPHS*

The Property Owner hereby consents to and authorizes the use of the Photographs by the Photographer and the Photographer's authorized representatives, licensees, successors, and assigns for any purpose whatsoever including without limitation: sale, reproduction in all media, publication, display, broadcast and exhibition or promotion, advertising, trade, art or illustration. The Property Owner agrees the Photographs may be used without further compensation for an unlimited time and that this Agreement is irrevocable.

4. *OWNERSHIP AND RIGHTS IN THE PHOTOGRAPHS*

The Property Owner agrees that the Photographs, the copyright in the Photographs and all other rights in the Photographs or copies or reproductions thereof are the sole property of the Photographer and that the Photographer may protect the copyright or dispose of or authorize the use of any or all such rights in any manner whatsoever.

5. *RELEASE OF PHOTOGRAPHER FROM LIABILITY*

The Property Owner releases the Photographer and all other persons entitled under this Agreement to use the Photographs, from all liability for libel, invasion of privacy, and all causes of action whatsoever in relation to the Photographs, their making and use, the Property Owner and/or the Property including without limitation any liability for alteration of the Photographs, whether intentional or otherwise, that may occur during the making or subsequent use of the Photographs.
